### **General Information**

#### Mission and Vision

The Osher Lifelong Learning Institute at the University of Delaware in Dover offers opportunities for intellectual development, cultural stimulation, personal growth and social interaction for people age 50+ in an educational cooperative.

Members volunteer their wealth of talent and experience in planning and implementing college-level educational experiences to form an educational cooperative. The members are the instructors and students, and through a committee structure guide the operating policies, develop curriculum and help with daily operations. No educational prerequisites are needed and there are no grades or exams—just learning for the fun of it.

#### Schedule

Classes are conducted in the Modern Maturity Center in Dover on Tuesdays and Thursdays during the day for a 10-week semester. The Fall 2013 semester begins Tuesday, September 10, 2013 and ends Thursday, November 14, 2013. Each class meets once a week for approximately one hour and 15 minutes. A full calendar is located on the inside of the front cover.



#### Membership

Membership is open to men and women 50 years of age and to members' spouses or partners at any age. Whether your formal education ended early in life or includes advanced degrees, we welcome you. An interest in learning is all that is required.

**Members** complete a registration form and pay the membership fee for the full year or the current semester.

**Full year** memberships begin with fall registration and expire on September 1 of the following year. Full year memberships include fall and spring semesters and are only available for purchase during the fall semester.

**Single semester** memberships begin upon registration for the fall or spring semester and expire on the first day of the subsequent semester.

#### **Course Registration**

You may register by mail or in person with the *Membership Registration Form* and the *Priority Selection Form*, together with payment, at the Dover office, 1121 Forrest Ave., Dover, DE 19904. Make checks payable to "University of Delaware." See the *current semester's calendar* for registration deadlines (inside front cover). Online registration and payment is available at www.lifelonglearning.udel.edu/dover.

**Maximum class size is 25.** Also, many class sizes will be limited by instructors' preferences. Unfortunately, some of these classes are the most sought after. Consequently, registration

procedures will include the following system.

- You may register for as many classes as you like but please only sign up for those you intend to take—and DO NOT sign up for multiple courses in the same time slot.
- You will be given an opportunity to identify your three priority course selections (Priorities 1, 2 and 3).
- All registrations received by the priority registration deadline are assigned in the following order:
  - First, priority selections, in order of priority (by random draw, if selections exceed seats available)
  - Then non-priority selections
  - Finally, registrations received after the priority deadline, and multiple registrations for the same time slot will be processed on a space-available basis.

You may register by mailing the *Membership Registration Form* and *Priority Selection Form* to the address shown at the top of the form. Additional forms are available at www.lifelonglearning.udel.edu/dover/ or by calling 302-734–1200 ext. 168. Telephone registration is not available.

- In-person registrations are also available in the Osher Dover Lifelong Learning Office at the Modern Maturity Center (see calendar for this semester's dates).
- Late registration—Registrations received after the priority registration deadline will be processed on a space-available basis.

  Registrations will continue to be accepted after the semester begins.
- Waiting list—Members who were not enrolled in a class during the previous semester because of over-subscription will be given preference this semester if the identical class is offered again. However, you must register for the class by the priority registration deadline and indicate the class as your first priority on your registration form.

#### **Fees**

Semester membership: \$140 (Fall 2013); \$235 (full year).

The membership fee entitles you to take as many courses as you like. The program depends almost entirely on registration fees, which are applied against operating expenses, including rent for the classroom spaces, staff salaries, and the cost of printing and postage. Full year membership is available for purchase in the fall only.

#### **Financial Assistance**

Need-based partial scholarships are available. For scholarship information, contact the program coordinator at 302-734-1200, ext. 168 to schedule an appointment.

#### **Other Programs**

Members can enjoy other program benefits such as the lunchtime speaker series, trips and social events.

#### **Travel**

Osher Lifelong Learning sponsors trips to enhance our educational experience. Many are one-day trips associated with particular courses. Information about these trips, including sign-up dates are posted on the kitchen counter. Members have first priority, and a surcharge is required of nonmembers. Once final payments have been made there are no refunds. Members who must cancel are encouraged to use the waiting list to find substitutes.

#### Refunds

Membership refunds will be given until the end of the second week of the semester. All requests must be made in writing and submitted to the office. Refunds will be processed no sooner than September 26, 2013. A \$15 processing fee will be deducted from all refunds.

Classes begin Tuesday, September 10, 2013 at 9 a.m.

#### **ART**

#### **AA115 Oil Painting**

Thursday, 1–3:45 p.m.

Dates: 10 Sessions, September 12-November 14

Instructor: Jan Miller

This class is for beginning and previous painters. It will examine how to get started, mixing oil paint colors, composition, how to care for brushes and other tools. We will have ample time to paint in a relaxed atmosphere. It is recommended, but not required, that students have taken a drawing class. A list of supplies will be distributed. Approximate supply cost will be \$40. This is a double time period class. Jan will be assisted by Lisa Trala.

#### AA155 Introduction to Northern Renaissance Art

Thursday, 1–2:15 p.m.

Dates: 10 Sessions, September 12-November 14

Instructor: Art McLaughlin

This course will focus on the concepts and historical factors which contributed to the development of the transition from the Gothic style to the Renaissance style in northern European painting. Emphasis will be on the well-known painters of Germany and the Netherlands. Some artists covered will be: Dürer, the van Eyks, Bosch, Gropius, and Pieter Bruegel the Elder. We will briefly discuss Renaissance painting in France and England.

**Art McLaughlin** holds a B.A in both political science and in art history from the University of Delaware. He is currently a graduate student in art history at the University of Delaware. He also holds an A.S. in respiratory therapy and an M.S. in community health and wellness administration. In addition, he is author of six textbooks on medically-related topics.

This will be discussed in the framework of the Western history of looting art, both in Europe and in the United States. Finally, we will look at the policies of Russia relative to looted art during WWII.

The material is delivered in a user-friendly manner intended to enable students to challenge themselves toward applying what they have learned.

Thursday, 1–2:15 p.m.

Dates: 10 Sessions, September 12-November 14

Instructor: Robert Mahaffey

An examination of the political, social and cultural traits of Colonial America. From the lure of European discovery to the American Revolution. Major topics include: displacing the Native Americans in the English colonies, a close look at Africans and Europeans, an overview of the middle colonies, New England and the southern colonies, the colonial political word, imperial breakdown and the road to revolution. The course will conclude with the American war for independence which will cover the Declaration of Independence and the founding fathers. Special topics include: colonial poetry, colonial money and revolutionary war uniforms.

**Robert Mahaffey** received his B.A. in American history and political science from the University of Delaware. He completed a black studies program at Delaware State University. Robert acted as director of training and management development for McDonalds. He was the certified trainer at Hamburger University and the National Sanitation Foundation (NSF).

## HX195 The Eloquent Presidency of John F. Kennedy

Thursday, 9-10:15 a.m.

Thursday, 10:30-11:45 a.m.

Dates: 10 Sessions, September 12-November 14

Instructor: Dan Pritchett

This course will examine the 1,037-day presidency of John Fitzgerald Kennedy by looking at both his words and deeds. His remarkable eloquence will be noted by listening to (and reading) some of his greatest speeches. His increasing mastery of the job of chief executive will focus on his handling of two tense confrontations: The Cuban Missile Crisis of 1962 and the showdown with Governor George Wallace at the University of Alabama in 1963.

Dan Pritchett received a B.S. in social studies education, Concord College; and a M.A. in American history, University of Delaware. Dan held a teaching position in the Capital School District, where he taught American history for 34 years. He later taught at both Wilmington and Delaware State universities. He is a member of the Lincoln Forum, one of the foremost national organizations dedicated to the study of Abraham Lincoln and his era.

#### HX200 Reading the American Past— Part 2

Tuesday, 2:30–3:45 p.m.

Dates: 10 Sessions, September 10–November 12

Instructor: Kevin McGrath

Using the primary source documents of *Reading the American Past, Selected Historical Documents*, Michael P. Johnson (editor), Volume 2 (fourth edition): from 1865. We will cover the periods Reconstruction through World War I. We will examine selected readings covering the political,

social and cultural history of the United States. Short readings representing major political addresses, period writing and documents reflecting the period will be explored. During this comparative broad-based discussion, questions will be utilized to emphasize teaching points and link readings to the period.

**Kevin McGrath** received a B.A. in history from Mt. Carmel College, Niagara Falls, Ontario. He retired as a human resources management professional, and has held management positions with ITT, Nortel Networks and Comshare. His interests include American history and reading.

#### HX205 Victory at Sea—Part 2, the European and Mediterranean Theaters of WWII

Thursday, 1–2:15 p.m.

Dates: 10 Sessions, September 12–November 14 Instructor: Doug Miller

This course begins with the *Victory at Sea* episodes covering the U-boat threat and how the Lend-Lease Act effectively brought us into war before Pearl Harbor. It also addresses how Hitler and Mussolini's pact threatened the Royal Navy in the Mediterranean, and how the Axis threat to capture the Suez Canal brought on the conflict in North Africa. The course will also include a study of Hitler's threat to Great Britain, Germany invading the Soviet Union, Stalin's pressure on the U.S. to enter the war leading to the Allies invading Italy and France, and the U.S. Navy's role in the invasions with firepower and supply.

**Doug Miller's** career includes teaching fifth grade social studies and language arts in the Caesar Rodney School District. He has conducted communication/navigation equipment training for Dover Air Force Base reservists. Doug has served as a historical



interpreter at the John Dickinson Plantation. He has been building model airplanes since he was a child and has been able to get close and personal with many naval World War II aircraft.

Special attention will be given to the contributions by women and minority groups. We will examine Southern Reconstruction (1865-1877), the westward expansion, the Progressive Era, the world wars, the Great Depression, the Cold War, the Civil Rights Movement and end with the events leading up the 21st century. ### HU155 Great Short Stories by American Women


Thursday, 9-10:15 a.m.

WHAT WAS SHE THINKING? Continuing our Osher poetry excursion into our culture's collective "interior life"—successfully having brought our bus from out of hell (our trip last semester journeyed into Dante's Inferno, a master-work that emblemized his mid-life crisis)—our poetry class will now journey into the universe of Milton's poetic tale of Adam and Eve. Come see how Eve is the real heroine of Eden, and how Adam "just doesn't get it." Come see how Satan gets his just desserts. Come see how the Archangel Raphael is so thoughtful, and how Archangel Michael has a really hard head. Then ponder the significance of God and of the universe. Or just come to see what happens or, more precisely, how it all happens! Enjoy reading this wonderful work of literature from the past that has eternally felt to so many "in the present." Interspersed along the course will be class analysis of other individual poems inbetween our stops through Milton's paradise!

Russ Endo, a professional poet, received his B.A., cum laude, in combined literature from Yale College. He obtained a *juris doctor* from the University of Pennsylvania Law School. Russ has been published in many publications including *Journal of Biological Chemistry*, *American Friends Delegation Report on China after Tiananmen Square, American Poetry Review, The Antioch Review, Ploughshares*, and the *Philadelphia Inquirer*. His poem, "Susumu, My Name" was the basis for a jazz orchestration by Sumi Tonooka that appeared on PBS. He currently sits on the boards of Wilmington Friends School and Greene Street Friends School in Philadelphia.

After serving a two year mission for his church, he returned to Brigham Young University for a master's degree in family life education. From there he moved to the University of North Carolina in Greensboro where he earned his doctorate in child development in 1984. He has taught and published his research at Southeast Missouri State University and at the University of Delaware. He taught at the University of Delaware for 20 years as an associate professor.


